3. Defendant(s) request(s) that the Plaintiff refrain from causing execution of the Writ of Possession, and to induce Plaintiff to withhold execution of the Writ of

7. That the Defendant is not currently enlisted in the military service and waives any defense as to such.

8. An affidavit signed by the Manager of \_\_\_\_\_ or the Attorney for the Plaintiff, stating that the Defendant has failed to make payments as agreed and stating which of the above payments remain unpaid shall be sufficient to cause the execution of the Writ of Possession.

9. Defendant(s) withdraw(s) any Answer or other defensive pleading, if any, filed by Defendant(s) in this case, and by signing this Agreement waives the right to further notice of any proceeding or hearing in this case.

10. Defendant(s) agree(s) to abide by all provisions of the Apartment Lease Agreement (previously signed) not in conflict with this Stipulation. In the event of any conflict between the Apartment Lease Agreement and this Stipulation, this Stipulation shall control.
